After that Mr. Milan SureshbhaiGanatra the thanked all the members present at the meeting. Then after the Chairman declared, the meeting was concluded.

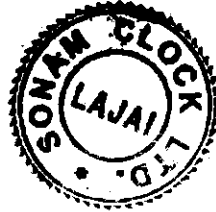
